I. Name of Committee

II. Specific Purpose of Referendum Advisory Committee

The Board of Education and the administration value public engagement and input. The Referendum Advisory Committee is a committee that will serve in an advisory role to the Barrington 220 Board of Education. The Referendum Advisory Committee is designed to provide perspective from the Barrington 220 community to determine which components of the Blueprint 220 Master Facility Plan should be included on a referendum question planned to appear on the April 2, 2019 ballot. The Referendum Advisory Committee will make a recommendation to the Board of Education by November 20, 2019.

The final decision of what will be asked on a referendum question rests with the Board of Education.

III. Advisory to the Board of Education

The Referendum Advisory Committee will bring a recommendation to the Board of Education for their consideration that meet with the approval of at least 60% of the group.

IV. Options and Modifications to be Considered by Referendum Advisory Committee

The Board of Education will present three (3) options for consideration and review by the Referendum Advisory Committee. The Committee may consider modifications to the three (3) options only after getting Board approval for such modifications. Any such modifications should be presented to the Board no later than the Board Meeting scheduled for November 6, 2018.

V. Referendum Advisory Committee Membership

The organizations below will be invited to provide a representative/s to serve on the Referendum Advisory Committee. Each representative is required to attend 75% of the Committee's scheduled meetings to vote on the Recommendation.

The Board will appoint up to 3 co-chairs to facilitate the meetings of the Committee. The co-chairs will not be voting members.

Additional input may be provided upon the request of the Committee co-chairs by staff members from the district. These additional individuals will provide their expertise and will serve as resources, not as committee members.

VI. Referendum Advisory Committee Community Representative Selection Criteria

Referendum Advisory Committee members must be able to:

- ✓ effectively and fairly represent the interests of the entire Barrington community
- ✓ attend the following scheduled meetings; (a) Monday, October 8; (b) Monday, October 22; (c) Monday October 29; (d) Monday November 12. All meetings will begin at 7:00pm.
- ✓ base their decisions on all relevant information and data and not on any singular issue.

VII. Referendum Advisory Committee Community Representative Selection Process

1. Each group or organization included in the Committee list will be invited to nominate a representative. The name of each organization's representative shall be submitted to the Board no later than Wednesday, September 26, 2018. If an organization does not submit a representative by the deadline, the Board will conclude the organization has decided not to participate in the Committee.

VIII. Referendum Advisory Committee Process
Open Meetings

All Referendum Advisory Committee meetings will be open to the public per the Illinois' Open Meetings Act. The Superintendent, or designee, will be responsible for ensuring that notification and documentation requirements are met.
