PROOF OF RESIDENCY

THREE documents are required to verify residency. You must submit proof of residency within Barrington 220 boundaries by providing **ONE document from Category I AND TWO documents from Category II.**

All documents must be current (within past 45 days) and include parent/guardian name and address.

Residency is determined by where a student resides. Only students who are residents of the District may attend a District school without tuition charge. A student's residence is the same as the person who has legal custody of the student.

STEP 1 - Category I: (ONE document required)

HOMEOWNERS:

- Most recent Property Tax Bill
- Mortgage Statement (homeowner)
- Real Estate Closing Document (for closing within last 60 days)

RENTERS:

- Signed and dated Lease with landlord's phone # listed
- If a lease is not available***, a Notarized Letter of residence from landlord
"Affidavit in Lieu of a Lease" is required.
(Ask Registrar for Affidavit and Instructions)
- If you reside with relatives or other individuals who live within Barrington 220 Boundaries***, a Notarized "Letter of Residence to Be Used When the Person Seeking to Enroll a Student is Living with a District Resident Affidavit" is required.
(Ask Registrar for Affidavit and Instructions)
